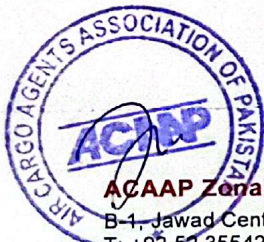


To fill in the casual vacant seat of Member of Executive Committee and the seat of Senior Vice Chairman ACAAP for remaining tenure of the term 2024-2026. Midterm Election of ACAAP was held as per the Election Schedule announced on 1<sup>st</sup> November 2025.

General Membership of ACAAP were invited to send their nomination whoever willing to contest in this election on the vacant seat of Executive Committee and the Senior Vice Chairman ACAAP. As per the announced election schedule till the last date and time only one nomination paper from Mr. Tariq Mahmood, Group CEO/Chairman of M/s. Dynamic Shipping Agencies (Pvt) Ltd. was received.

As per TO-Rules 2013, Members of Election Commission scrutinized his nomination paper and found it correct and eligible to contest for the seat of Executive Committee. Since there was no other candidate filed his/her nomination for this casual vacant seat of Executive Committee, therefore, Mr. Tariq Mahmood, Group CEO/Chairman of M/s. Dynamic Shipping Agencies (Pvt) Ltd. is declared elected unopposed on the casual vacant seat of Executive Committee of ACAAP for the remaining tenure of the term 2024-2026

Further, to contest for the casual vacant seat of Office Bearer (Senior Vice Chairman ACAAP) nomination from elected members of Executive Committee were invited. Only one nomination from Mr. Tariq Mahmood the newly elected Member of Executive Committee was received. As per the TO-Rules 2013 his nomination paper was scrutinized by the Members of Election Commission who found it correct and qualified for contesting the election on the casual vacant seat of Office Bearers (Senior Vice Chairman ACAAP).




