The House was informed that in the past, the association's funds were mishandled by the previous Executive Committee and Office Bearers on foreign travel and tours without prior approval of the budget from the Executive Committee. Some members suggested that the Executive Committee should investigate this matter and take appropriate action against individuals who misused their authorities and mishandled ACAAP funds in the past.

Mr. Jamil Ahmed applauded and appreciated the efforts of the Interim Committee of ACAAP for streamlining the affairs of the association and bringing it onto the right track

Therefore, on the proposal of Mr. Khalid Mir, Member of the Executive Committee, seconded by Mr. Nadeem Khalid Lone, Vice Chairman of ACAAP, the minutes of the last AGM 2023 were approved and adopted by the House.

Point No.3

Consideration and approval of Financial Statement/Income and Expenditure Account of the Association for the year ended 30th June 2024.

Financial Statement/Income and Expenditure Account (Auditor's report) of ACAAP for the year ended 30th June 2024 was taken up.

Mr. Muhammad Saleem Butt asked for the reasons for the increased expenditure in the ACAAP-KHI office rental, considering that the association was already operating at a loss. He also inquired about the plans to cover this increased expenditure. His query was satisfactorily addressed by the house.

Mr. Muhammad Saleem Butt also made an observation regarding the confusion and purpose of showing the General Purpose Fund in the statements, and suggested a review of the presentation of financial statements in a proper and transparent way for better understanding by all members in the future. The query was addressed by the house, and it was assured that the newly elected Executive Committee will handle it in a more refined manner.

After a brief discussion, the House had no objection to the report. The Financial Statement/Income and Expenditure Account (Auditor's report) of ACAAP for the year ended 30th June 2024 was approved and adopted by the House.

Point No.4 Declaration of the results of the Annual Elections of ACAAP for the year 2024-2026

The final results of ACAAP's elections for the year 2024-2026 were announced. The results were read out by the Secretary-General before the House.

Mr. Khalid Masood raised an objection to the announcement of the SVC result due to a complaint filed with the DGTO by himself, and the decision is pending. Due to the complaint lodged by himself before the DGTO and the fact that the matter is subjudice, no reply was given by the house.
