**Announcement of Elections Schedules of ACAAP &
Bye-laws For the Elections of Executive Committee and Office Bearers
for the term 2021-2022**

We are pleased to inform all members, that the Meeting of Executive Committee (EC) was held on Tuesday 29th June 2021 simultaneously at ACAAP's Head Office, Karachi and ACAAP's Regional Office Region 'B', at office No.B-1,Jawad Center, Defence Road, Sialkot (via multimedia, video link).

The Executive Committee has approved the **Election Schedule for the term 2021-2022 and appointed Members of Election Commission** with their consent to conduct the Election process.

Last date: Submission of Nomination papers for Executive Committee is 16th August 2021 by 5:00 PM at ACAAP's Head Office at address, Suite # 305, Fortune Centre, 45-A, Block-6, PECHS, Shahrah-e-Faisal, Karachi

The eligibility to vote or to participate in election shall be complied in accordance to Rule 15 of TOR-2013 and Articles of Memorandum & Articles of Association of Air Cargo Agents Association of Pakistan.

Members who are interested in contesting elections for the vacant seats of Members for Executive Committee can obtain upon written request.

Member eligible to contest elections for the vacant post, shall send his nomination duly proposed and seconded by a registered voter and signed by the candidate to the Secretary General on the **prescribed Proforma for Nomination for Election** which can be obtained from ACAAP's Head Office or ACAAP's Regional Office Region 'B' upon written request.

- **Nomination papers** for Election of Executive Committee should be dispatched either by Registered post/courier or maybe delivered by hand in a way that it should reach ACAAP's Head office within the stipulated time.

- Envelope shall be in the name of **Election Commission** and be marked “**Nomination for Election of “Executive Committee”**”.
- The Electoral College for each class of members of Executive Committee shall be the members of General Body from the respective class and Electoral College for Office Bearers shall be elected by the Executive Committee.
- Nomination papers received after scheduled time shall not be eligible for elections.
- Nomination Proforma should be filled in Original and should be completed in all respects. Incomplete Proforma will be invalid.
- Photocopy of proforma will not be accepted.
- Any cutting erasing or over writing shall make the proforma invalid.

Please note:- Members who have not yet submitted their Official Representative Form (provided in Original) as per Rule 15 (2) and Specimen Signature Card (on their company’s letterhead) as were asked this year during Renewal of Membership are requested to submit immediately.
