**Announcement of Elections Schedules to Elections Members of Executive Committee and Office Bearers of ACAAP for two years term 2024-2026**

Dear All Member,

We are pleased to inform you that the Interim Committee of ACAAP in its meeting held on 12<sup>th</sup> July 2024 has approved the **Election Schedule for the term 2024-2026 and appointed Members of Election Commission** with their consent to conduct the Election process of ACAAP as per TOA/TOR 2013, Trade Organization's (Amended act) 2022 & DGTO Notification No.17(31)/2008-TO dated 27<sup>th</sup> June 2024. The Election Schedule and Rules-15 of TOR-2013 concerning Eligibility to vote are attached and uploaded on ACAAP's website [www.acaap.org](http://www.acaap.org)

Member Company desiring to change name of its representative in the Voters List shall intimate Secretary General in writing along with necessary proof of eligibility within three (3) days of announcement of Election Schedule i.e. by Thursday 18<sup>th</sup> July 2024 upto 5:00 pm Official Representative Form & (format of Specimen Signature Card is attached).

The eligibility to vote or to participate in elections shall be complied in accordance to Rule 15 (2) of TO Rules and Articles of Memorandum & Articles of Association of Air Cargo Agents Association of Pakistan.

**Members who are interested in contesting elections for the vacant seats for Members of Executive Committee can obtain Nomination Forms upon written request from Head Office ACAAP at Region 'A' or ACAAP's Regional Office at Lahore or Zonal Office at Sialkot.**

Member eligible to contest election for the vacant seat of Executive Committee, shall send his nomination duly proposed and seconded by a registered voter and signed by the candidate to the Secretary General on the **prescribed Proforma for Nomination for Elections**.

**Please note that:**

- As per TO (Amendment) Act 2022, the tenure of the Office Bearers shall be two (02) years
- Elections for the tenure 2024-2026 will be held to Elect all twelve (12) Members of the Executive Committee.
- As per Rule 21(6) of Trade Organizations Rules-2013 and Article 20(ii) of Memorandum & Articles of Association of ACAAP, Electoral College for two (2) reserved seats for women entrepreneurs, shall be the Executive Committee. (Nomination forms shall be issued from the Head Office vide a separate circular)
- The eligibility to vote or to participate in election shall be as per Rule 15 of TOR, 2013, M&AoA of ACAAP and in accordance with the official Representative Form furnished by the member to the ACAAP's Secretariat.

- **Last date: Submission of Nomination papers for Executive Committee is 26<sup>th</sup> August 2024 by 5:00 PM at ACAAP's Head Office** at address, Suite # 305, Fortune Centre, 45-A, Block-6, PECHS, Shahrah-e-Faisal, Karachi
- **Nomination papers** for Election of Executive Committee should be dispatched either by Registered post/courier or maybe delivered by hand in a way that it should reach ACAAP's Head office within the stipulated time.
- Envelope shall be in the name of **Election Commission** and be marked "**Nomination for Election of "Executive Committee"**."
- The Electoral College for each class of members of Executive Committee shall be the members of General Body from the respective class and the Office Bearers shall be elected by the Elected Members of the Executive Committee.
- Nomination papers received after scheduled time shall not be eligible for elections.
- Nomination Proforma should be filled in Original and should be completed in all respects.
- Incomplete Proforma will be invalid.
- Photocopy of proforma will not be accepted.
- Any cutting erasing or over writing shall make the proforma invalid.

Members are requested to follow the announced Election Schedule accordingly.
